

Briefing Sessions on "Earn & Learn Pilot Scheme for Retail Industry"

To address the current manpower shortage and groom a quality labour force for the retail industry, the Financial Secretary announced in his 2014-15 Budget an allocation of \$130 million to support manpower development of the retail industry. One of the foremost initiatives is the launch of the Earn & Learn Pilot Scheme for Retail Industry which is jointly organized by the HKRMA and the Vocational Training Council (VTC).

The Association sincerely invites member retailers' to participate in the "Earn & Learn Pilot Scheme for Retail Industry".

Benefits to Retail Employers

- > To recruit a pool of new blood
- To ease pressure of manpower shortage
- > To lessen the training pressure as VTC will train student-workers according to a well devised curriculum
- > To develop and retain a dedicated and trained workforce in the long run

About the Scheme

- Secondary 6 leavers (student-workers) have to attend 3 days class per week on Foundation Diploma on Retail (QF Level 3) organized by VTC
- > Student-workers will acquire work experience with participating employers for another 3 days per week
- Participating employers will sponsor part of the tuition fee for student-workers and guarantee their salary level during the Scheme
